- 4. The 2nd Defendant is prohibited from publishing or republishing the substance of the allegations in Annex 1 in any form.
- 5. The 2nd Defendant must remove forthwith any allegations the same as or in substance the same as those set out in Annex 1 from any other place in which they have been published.
- 6. Nothing in this order prohibits the 2nd Defendant from taking legal advice or communicating any information to a legal advisor necessary to do so.
- 7. The Claimant has leave to publish this order as he sees fit.
